MARCUS BLAIN TRIAL Round 2 AGA Ulster Championship

1. **Jurisdiction.** The event will be held under the General Competition Rules and Standing Regulations of the Motor Cycle Union of Ireland, Motorcycle Racing Association Ireland and these Supplementary Regulations.

2. **Eligibility.** The event is open to drivers holding a current competition licence issued by the MRA, MCUI, ACU or SACU. The promoters require holders of ACU and SACU competition licences to show evidence of the required Medical Expenses and Repatriation cover before permitting a start. Unlicensed riders may compete on a one day license. **To be eligible for Championship points rider must display the grade sponsor on the number board of the bike.**

4. **Officials.**

5. **Youth Entries.** Entries must be made on the official form, complete in every detail and accompanied by **ENTRY FEE: - Seniors £30 Youth A, B, £15 Youth C, D, E, Minders £5.** To secretary of event: -

6. **Classes.** The trial will be for Grades Expert elite, Expert, Semi-expert, Clubman, Sportsman, Youth Grades A, B, C (big course). Junior C, D, E will have a separate course in an allocated area, if sufficient entries received. They must remain in this area while the main trial is in progress. They are not permitted to ride on the main course.

7. **Course.** The course will be marked with direction arrows or flags indicating the desired route between sections.

8. **Start and Finish.** Drivers will be started by timekeeper per grade and sign off by presenting punch card at the finish **particularity on retirement.**

9. **Time.** The time allowed to complete the trial shall be announced at the start. **Anyone who does not start at the due time will receive no allowance of time for late starting.**

10. **Sections.** The No of sections and laps to be defined at start, must be attempted in the correct order. The sections will be indicated by **Start Markers** at the start and **End Markers** at the finish. In between coloured gates to coincide with rider's bib colour.
